1. General Terms and Conditions

- ☐ The Show Organisers reserve the right to alter the schedule, change times or arenas, and reject any entries at their discretion.□
- ☐ By submitting an entry, competitors confirm they have read and accepted these terms without reservation.□
- ☐ Competitors are responsible for the accuracy of their entries. Errors caused by riders or their representatives are not the responsibility of the Organising Committee.□
- ☐ Withdrawals must be emailed to: **admin@millstreethorshow.ie**. The app's withdrawal button is not valid for official notification and will not qualify for a refund.□
- ☐ All online entries must be complete. Stable bookings without corresponding entries are invalid.□

2. Entries

- ☐ All entries must be submitted via: **www.millstreet.horse**. Other submission methods will not be accepted.□
- ☐ Entries without full payment will be declined.□
- ☐ Late and conditional entries are not accepted.□
- ☐ Withdrawals may be refunded post-show, minus a €15 booking fee.□
- ☐ Substitutions in national classes are allowed only at the discretion of the Organising Committee. Either horse or rider can be substituted, not both. Horses can only be substituted if they are eligible for the class in question.□

3. Stabling

- ☐ Stabling fee: €160 per horse for the show duration. Must be pre-booked and prepaid via Equipe.☐
- ☐ On arrival, present your stable number and passport. Random microchipping and passport checks will be conducted of National Horses.☐
- ☐ FEI Horses will be checked in by FEI Veterinarians in line with FEI Veterinary Regulations.☐
- ☐ Stable modifications or blocking aisles/doors are not allowed. Unauthorized stable use is prohibited.☐
- ☐ Stallion owners must provide their own electric fencing.☐
- ☐ Vaccinations must be up to date. Non-compliance results in withdrawal of entries and removal from the show grounds.☐
- ☐ Stabling cancellation refund (50%) available only if requested before 14 July 2025. No refunds after this date.☐
- ☐ Stables open from 14:00, 22 July. Grounds close at 21:00 nightly.☐

Ground Rules:

- ☐ No scooters, quads, MPVs, or tents.☐
- ☐ Dogs must be leashed at all times.☐
- ☐ The Show Organisers are not liable for any accident, loss, or damage.☐

4. International Horse Classes

Entry & Participation:

- ☐ Enter via **Equipe and** through your National Federation. One without the other is not a complete entry.☐
- ☐ Closing date of FEI Entry system: **17 July 2025**.☐
- ☐ Refunds for non-runners will retain a 50% booking fee.☐

Passports & Health Checks:

- ☐ Horses must be vaccinated in line with FEI Regulations.☐
- ☐ Passports must be presented at check-in located in the indoor warm up arena. Entry to stabling is denied until submitted.☐
- ☐ Substance control testing for athletes and riders may be conducted at this show.☐
- ☐ Riders are responsible for ensuring vet check-in and temperature logging per FEI rules.☐
- ☐ Rider/PR (Person Responsible) must follow relevant FEI Temperature checks prior to arrival at the show grounds.☐

Stabling Requirements:

- ☐ FEI horses will be stabled in a separate air space to national-level horses in line with FEI Biosecurity Regulations.☐

- ☐ Stabling requests submitted at the time of entry will be accommodated if it is possible.☐
- ☐ Horses must remain in the stable they were allocated unless permission is granted by FEI stewards and officials on site.☐

General Rules:

- ☐ Head numbers must be worn when horses are outside their stables.☐
- ☐ Riders are expected to follow all FEI Rules & Regulations while participating at this show. It is their responsibility to be familiar with all relevant rules.☐

Prize Money:

- ☐ Paid in Euros by cheque to the account holder named in the entry form, after the show.☐

Declarations & Dress Code:

- ☐ International Class declarations are due by 6 PM the day before.☐
- ☐ Riders must follow FEI dress code and wear assigned numbers.☐

Practice Arena & Behaviour:

- ☐ The starter has authority over entry. FEI rules apply in relation to proper tack, dress, and number.☐
- ☐ Inappropriate or cruel behaviour will result in penalties or disqualification.☐

Late Entries:

- ☐ Late entries for International Classes will not be accepted after 17 July 2025.☐

5. Millstreet International Grand Prix

- ☐ Qualifiers: 24th & 25th July 2025. Top 20 combinations from each proceed to the Grand Prix.(Intl comp 2 & 5)☐
- ☐ Prize Fund: Minimum €30,000.☐
- ☐ Qualified riders must declare by the time stated at the show office.☐
- ☐ Horse substitution is not permitted. Rider substitutions may be allowed in exceptional cases with written appeal.☐
- ☐ Further information to be found in Millstreet CSI2* FEI Schedule.☐

Automatic Qualification (FEI Art. 261.4.2):

- ☐ The following Athletes (not Athlete/Horse combinations) are automatically qualified for the Grand Prix at CSI Events, if present:☐
- ☐ 261.4.2.1 - The winner of that Event's Grand Prix the previous year;☐
- ☐ 261.4.2.2 - The current National Champion of the host country;☐

- 261.4.2.3 - The individual medal winners of the last Olympic and Pan-American Games, the last FEI World and FEI Continental Championships and the winner of the FEI World Cup™ Final.

6. National Classes

- Millstreet International Horse Show National Classes run under Irish National Competition Rules.□

Entries & Fees:

- Enter via: **www.millstreet.horse** using Equipe.□
- Deadline: **14 July 2025**. Late entries are not accepted.□
- Refunds will incur a €15 booking fee per entry.□
- A €20 First Aid fee will apply per account.□
- Finals must be paid for in full prior to the start list being drawn.□

Passport & Health Checks:

- All horses must be vaccinated in line with national competition regulations.□
- Random inspections and testing will occur throughout the event.□
- Boomerang and Ruby class entries must submit passports before the final.□

Rules:

- National horses will be stabled in a separate air space to FEI-level horses in line with FEI Biosecurity Regulations.□
- Stabling requests submitted at the time of entry will be accommodated if it is possible.□
- Horses must remain in the stable they were allocated unless permission is granted by stewards and officials on site.□
- Automatic declaration applies with a valid entry.□
- Substitutions are allowed only at the discretion of the Organising Committee. Either horse or rider can be substituted, not both. Horses can only be substituted if they are eligible for the class in question.□
- National classes follow National Competition dress code.□
- Abuse of a horse or other person at the show is not tolerated. Violators will be disqualified from the show and prize monies forfeited. Article 243 of the FEI rules for jumping events will apply.□
- Any official protests must be in accordance with FEI Protocol (Article 163-169).□
- Horse Head numbers must be worn by horses at all times when outside of their assigned stable.□
- All prize money will be paid in Euros. Prize money is paid by cheque drawn to the order of the account holders name and address as indicated on the online form and will be paid out after the show.□

7. Special Championships

Millstreet Ruby 5-Year-Old Championship Rules -Prize fund €28,000

Eligibility: Open to horses born in 2020.

Fence Heights:

- Qualifiers – 1.20m
- Final – 1.25m

Format:

- All horse/rider combinations must compete in both qualifiers.
- The **top 32 combinations** will qualify for the final based on total points across both qualifiers.
- Additional finalists may be invited at the discretion of the Organising Committee.

Rider Entry:

- Riders may enter **up to 4 horses** in the qualifiers.
- A maximum of **2 horses** per rider may qualify for the final — these will be the two with the highest total points.

Competition Format:

- **Qualifiers:** Table A
- **Final:** Table A, Article 238.2.2 – One Round Against the Clock with Jump-Off

Points System (per qualifier):

- 1st place = number of starters + 1
- 2nd = starters – 1
- 3rd = starters – 2
- and so on, until all starters receive points.

Tie-breaker:

- If combinations are tied on points, the better result (faults + time) in the second qualifier will determine qualification.
- If still tied, the first qualifier result will be considered.
- If both results are identical, both combinations may be accepted.

Other Rules:

- Entry via **Equipe** – block entry fee applies.
- No rider substitutions between qualifiers and final.
- Random inspections and anti-doping testing may be carried out.
- Performance-enhancing boots are not permitted.
- Horses should be capable of jumping technical tracks.
- **Breeder prizes** are supported by the **Department of Agriculture, Food and the Marine** and **Horse Sport Ireland's Breeding Grant Initiative**.
- **Breeding information must be submitted at the time of entry.** If unknown, please state "Not recorded."

Boomerang Finder 6/7-Year-Old Championship

6 & 7-Year-Old Championship Rules – Prize Fund: €38,000

Eligibility: Horses born in 2018 or 2019.

Heights:

- **6-Year-Olds:** Qualifier: 1.20–1.25m | Final: 1.25–1.30m
- **7-Year-Olds:** Qualifier: 1.30–1.35m | Final: 1.35–1.40m

Format:

- Two Table A qualifiers; riders must compete in both.
- Top 40 combinations qualify for the final based on total points. Additional finalists may be invited at the Organising Committee's discretion.
- Final: Table A, Article 238.2.2 (One Round Against the Clock with Jump-Off).

Entry:

- Riders may enter up to 4 horses in qualifiers; only their top 2 (by points) go forward to the final.
- No rider substitutions permitted between qualifiers and the final.
- Entry via Equipe. Block entry fee applies.

Scoring System:

- 1st place = number of starters + 1
- 2nd = starters - 1
- 3rd = starters - 2, and so on (minimum 1 point per starter).

Tie-Break: If tied on points, better result in the second qualifier decides. If still tied, first qualifier result is used. If still tied, both may qualify.

General:

- Horses must be capable of jumping technical tracks.
- Random inspections and anti-doping tests may occur.
- Performance-enhancing boots are prohibited.
- Breeder prizes funded by DAFM and supported by the HSI Breeding Grant.
- Breeding details must be submitted at entry. If unknown, write "Not recorded" on the entry form
- €1000 to each of the top 3 placed breeders.

8. Special Classes

Discovery Classes

- For 4-year-old horses, born 2021 that are broken and riding.□
- Judged on conformation and jumping ability□
- One qualifier with 15 advancing to a €15,000 final□
- Portion of the prize fund is funded by the Department of Agriculture, Food and the Marine and supported by Horse Sport Ireland Breeding grant initiative. See further information below under section 10□

Young Irelander (3-Year-Old & Small Horse)

- ☐ Loose jumping class
- ☐ Judged on conformation and jumping ability
- ☐ Standard class: For 3-year-olds, Prize Fund: €6,000
- ☐ Small Horse: For 3- and 4-year-olds, 148–160cm height, Prize Fund: €600
- ☐ Horse Young Irelander Funded partly by Horse Sport Ireland/DAFM, breeding must be entered at time of entry, please write 'not recorded' if breeding is unknown. See further information below under section 10

Eventing Discovery Class

- ☐ Section for 4 and 5-year old horses that are broken and riding.
- ☐ Prize fund: €10,000 (€5,000 per age category & winning breeder prize). Portion of the prize fund is funded by the Department of Agriculture, Food and the Marine and supported by Horse Sport Ireland Breeding grant initiative. See further information below under section 10.
- ☐ Marks awarded for conformation, movement, canter & gallop, natural technique/temperament, scope/agility & 5* potential for a total of 100 marks.
- ☐ No set flatwork test, combination of show jumps and cross country fences.

- ☐ 4 year old category: Max of 105cm.☐
- ☐ 5 year old category: Max of 110cm.☐
- ☐ Riders are confined to 3 entries across both age categories.☐
- ☐ Max of 30 entries per age category.☐

General Rules for Special Classes:

- ☐ Entries close: 14 July 2025☐
- ☐ Entry fees are non-refundable☐
- ☐ Passports must be handed in before the finals☐
- ☐ No hind jumping boots allowed☐

9. Passport & Substance Protocol

- ☐ Random blood testing will be conducted for all classes☐
- ☐ The following winners will be tested:☐
 - ☐ Boomerang Championship
 - ☐ Ruby 5-Year-Old Championship
 - ☐ 4-Year-Old National Discovery
 - ☐ 3-Year-Old Young Irishlander
 - ☐ Young Event Horse 4/5-Year-Old Discovery
- ☐ Positive tests result in disqualification and forfeiture of prizes at this and future shows. Refusal to test leads to loss of prize money.☐

10. Horse Sport Ireland Breeding Grant Initiative & Department of Agriculture, Food & The Marine.

The following classes at Millstreet International Show CSI2* 2025 are funded partly the Breeding Grant Initiative under National Breeding Services with thanks to the Department of Agriculture, Food and the Marine, and delivered by Horse Sport Ireland.

- National Discovery.
 - Ruby 5 year old championship. (Breeder's prizes: top 3 €1000 each)
 - Boomerang 6/7 year old championship. (Breeder's prizes: top 3 €1000 each)
 - Mares 1.20m Championship.
 - Young Event Horse Discovery.
- ☐ All horses in receipt of funds must be studbook registered with a specific breed documented within their studbook passport. This can include the main section studbook or the supplementary section studbook equines.☐
 - ☐ Prize winners must submit full payment details via the [linked payment form](#) within 14 days of the competition or they will not receive prize money.☐
 - ☐ Horse Sport Ireland have provided shows with a '[winners letter](#)' which will be provided to prize winners on the day of the show. The show will detail the placing and amount awarded. This letter includes details on how competitors redeem their prizes.☐

- ☐ The horse must be registered in the correct ownership, with the PIO, to be in receipt of prize funds. Foreign bred/registered horses must complete a movement notification before funding will be paid out.
- ☐ Riders will not receive prize funds until HSI has received permission, in writing or via email, from the registered owner of the horse.
- ☐ All entrants must ensure all information provided is accurate up to date.
- ☐ Horses must be endorsed/ notified to a DAFM Approved studbook where necessary.
- ☐ Horse Sport Ireland will not be responsible for unpaid prize monies due to failure by the competitor to submit their online form, equine ineligibility, failure by the show to supply the prize form to the competitor or incorrect bank details, contact details, email addresses, owner details and or prize results submitted to HSI in the show report or any grievances arising between show/event/initiative/class participant and the organiser.
- ☐ Breeder's prizes will only be paid to breeders residing on the Island of Ireland.

11. Data Protection

Millstreet Horse Show uses personal data solely for event administration including entries, stabling, publishing results, and processing payments. Data is handled by Equipe AB and not shared without permission. By registering, users consent to these terms. See our Privacy Statement for full details.
